## PLAYER PARTICIPATION AGREEMENT

### 1. GOVERNING AUTHORITY & DISPUTES

The Player, and where applicable the Parent or Legal Guardian, acknowledges and accepts the authority of ECVA, NORCECA, FIVB, and all appointed officials and governing bodies responsible for the event.

Sport-related disputes arising from competition matters shall be handled under applicable ECVA, NORCECA, FIVB, and event regulations, subject always to applicable law.

### 2. ELIGIBILITY & NATIONAL FEDERATION CONFIRMATION

The Player confirms that they meet all eligibility requirements for the event and that all required documentation and certifications have been completed in accordance with event regulations.

Where the Player is under 18, the National Federation and the Parent or Legal Guardian confirm that the Player is permitted to enter the event under the applicable competition and safeguarding rules.

The Player's National Federation confirms, by signature below, that the Player is properly entered, eligible, and authorized to participate in the event.

### 3. HEALTH, MEDICAL FITNESS & EMERGENCY CARE

The Player acknowledges the inherent risks associated with competitive volleyball, including but not limited to physical injury arising from training, competition, environmental conditions, and travel.

The Player confirms that they are medically fit to participate in the event and have disclosed any relevant medical condition, allergy, or medication to their National Federation and to event medical personnel where appropriate.

The Player authorizes team officials, event medical personnel, and emergency services to arrange or provide medical care, including transport to a medical facility, where this is reasonably considered necessary during the event.

#### 4. PLAYER RESPONSIBILITIES & CONDUCT

The Player agrees to:

- act professionally and respect officials, opponents, event staff, volunteers, facilities and equipment;
- be present and ready to compete at all scheduled match times and attend required technical meetings;
- comply with all applicable competition, disciplinary, uniform, sponsorship, accreditation, and event presentation rules;
- participate in reasonable media, promotional, and award ceremony activities as required by the event;
- always conduct themselves in a manner consistent with the rules referred to above and with the reputation of the sport.

#### 5. ANTI-DOPING & INTEGRITY

The Player acknowledges and agrees to comply with all applicable anti-doping rules and integrity regulations of ECVA, NORCECA, FIVB, and the World Anti-Doping Code, including the obligation to submit to testing as required.

The Player shall not engage in, and shall not knowingly support, any of the following:

- use, possession, trafficking, or administration of prohibited substances or methods;
- refusal or failure to submit to, or otherwise cooperate with, sample collection or any other element of the testing process;
- betting, in any form, on volleyball competitions in which the Player or their team is involved, or on any related event;
- match manipulation, the manipulation of any aspect of a competition, or the misuse of inside information;
- any other breach of applicable integrity, anti-corruption, or safeguarding regulations.

The Player agrees to report promptly any approach or information relating to potential integrity breaches to the appropriate authority.

#### 6. MEDIA & IMAGE CONSENT

The Player grants ECVA, NORCECA, FIVB, and authorized event partners a non-exclusive right to use the Player's name, image, likeness, voice, and performance-related content in connection with the event.

This consent covers, without limitation:

- event promotion and marketing;
- broadcast and live or recorded streaming;
- photography and video production;
- social media and digital channels operated by or on behalf of the relevant organizations;
- archives, historical records, and highlight content;
- sport development, educational, and non-commercial promotional use of the sport.

Such use may occur without additional compensation unless otherwise agreed in writing. Where a player is under 18, this consent is given by the Parent or Legal Guardian.

**7. EVENT CHANGES & LIABILITY**

The Player acknowledges that event schedules, formats, venues, or conditions may be modified, postponed, or cancelled due to circumstances beyond the reasonable control of ECVA or event organizers.

The Player accepts responsibility for their personal travel, accommodation, insurance, and other arrangements. Where the Player is under 18, the Parent or Legal Guardian accepts that responsibility on behalf of the Player to the extent that those arrangements are not provided by the National Federation or event organizer.

ECVA shall not be responsible for losses arising from circumstances beyond its reasonable control, except where liability cannot be excluded under applicable law.

**8. CONSEQUENCES FOR BREACH**

Breach of this Agreement or of any applicable rules or regulations may result in disciplinary action under the applicable framework, including warning, fine, suspension, disqualification, removal from the event, or referral to the relevant disciplinary, safeguarding, or anti-doping authority.

**9. FINAL TERMS**

This Agreement applies for the duration of the event and constitutes the full understanding between the Player (and, where applicable, the Parent or Legal Guardian) and ECVA regarding participation.

If any provision of this Agreement is found to be unenforceable, the remaining provisions shall remain in full effect.
